



## **CONSULTATION FOR PROPOSED ADMISSION ARRANGEMENTS 2016/2017**

The Admissions Code of Practice 2012 requires an Admissions Authority to consult each time it proposes to make significant changes to its admissions arrangements.

The STEP Academy Trust is the Admission Authority for Angel Oak Academy, Applegarth Academy, David Livingstone Academy, La Fontaine Academy, Gonville Academy, Heathfield Academy and Wolsey Junior Academy and administers the admission arrangements on behalf of the Local Governing Bodies of the above named Academies.

Accordingly, the Board of Directors of The STEP Academy Trust is undertaking this statutory consultation process with the parents and other stakeholders for the family of STEP Academies including:

- parents of children between the ages of two and eighteen;
- other persons in the relevant area who in the opinion of the admission authority have an interest in the proposed admissions;
- all other admission authorities within the relevant area (except that primary schools need not consult secondary schools);
- whichever of the governing body and the local authority who are not the admission authority;
- any adjoining neighbouring local authorities where the admission authority is the local authority; and
- in the case of faith schools, the body or person representing the religion or religious denomination.
