

## LA FONTAINE ACADEMY

### CATEGORY 4 (CHILDREN ELIGIBLE FOR PUPIL PREMIUM OR SERVICE PREMIUM) FORM

This form is to be completed by the parents of children who fall into Category 4, namely children who are eligible for Pupil Premium or Service Premium, and submitted by the application deadline. Failure to do so will result in the child being placed into the next category that applies.

The criteria for Category 4 are:

#### Children are Eligible for Pupil Premium or Service Premium

Children who meet the eligibility criteria for Pupil Premium (“PP”) or Service Premium (“SP”) at the application deadline will be allocated places in this category by reference to the proximity of the child’s home address (as defined by this policy) to the Academy, with those living nearer receiving higher priority.

Eligibility criteria for PP and SP are published online by the government and are subject to change.

At the time of developing this policy, eligibility for PP is based on eligibility for Free School Meals (“FSM”) at any time during the preceding six years. Eligibility for FSM from Year 3 (after universal eligibility ceases) is based on receipt of specified State benefits. Looked after and previously looked after children are also currently eligible for PP, however these children will always fall into Category 1 rather than this category.

At the time of developing this policy, eligibility for SP is based on the child having at least one parent who is a member of the UK Armed Forces, or ever has been since the January 2011 School Census) or receiving an armed forces pension following the death of a parent while serving in the UK Armed Forces.

The reference to “eligible” in this policy, however, means eligible at the application deadline, under government criteria published at that time.

**The same parent who completed the Common Application Form (“CAF”) must complete and sign this form.**
